



2018-2019 Direct Parent PLUS Loan Request Form

To be completed by the parent(s) of a dependent undergraduate student who wishes to apply for the Federal Direct Parent Loan (PLUS). The borrower must be a U.S. citizens or an eligible non-citizen.

Steps to obtain a PLUS loan:

- Secure a PLUS credit decision. Go to www.studentloans.gov and sign in using your Federal Student Aid ID.
- Click on the “Request PLUS Loan” link on the left side of the screen under the “PLUS Loan Process” heading.
- Select “Parent PLUS” as your loan type and complete credit check.
- If you are approved, complete your Master Promissory Note (MPN).
- Click the “Complete MPN” link on the left side of the screen and choose the “Parent PLUS option” and you will be guided through the process.
- If you are denied, see your options below in the “Credit Check Information” box.
